## **TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these terms and conditions. Any entry not complying with these terms and conditions is invalid. Participation in this promotion is deemed acceptance of these terms and conditions.
2. Entry is open to Australian residents, with no limit on the number of entries per person. Directors, management and employees and their immediate families of the promoter and agencies associated with the promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (including adopted children), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

4. All entries remain the property of the promoter.

The promoter does not accept responsibility and is not liable for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence due to error, omission, tampering, deletion, theft, communications failure or otherwise. Any attempt, deliberate or otherwise, to cause malicious damage or interference with the normal functioning of the competition website or the information on the competition website, or to otherwise undermine the legitimate operation of this competition may be a violation of criminal and civil laws and, should such an attempt be made, whether successful or not, the promoter reserves the right to seek damages to the fullest extent permitted by law.
