<b>Eligible Entrants</b>	<p>Entry is open to residents of Australia, excluding Tasmania, aged 18 years and over.</p> <p>Entrants must be a Registered Cardholder of the Woolworths Rewards Program to enter. “<b>Registered Cardholder</b>” means a holder of a Woolworths Rewards card issued by the Promoter, excluding temporary cardholders (who are not eligible to enter or win prizes under this Promotion).</p> <p>Employees of the Promoter directly involved in the Promotion and their immediate families are ineligible to enter.</p>

## ADDITIONAL TERMS
