- 4. All entries remain the property of the promoter.
- 5. The competition commences at 12:01am 1 July 2021. Entries close at 11:59pm 28 July 2021.
- 6. Entries are deemed to be received at the time they are received by the promoter's database and not at the time of submission by the entrant. The promoter does not accept responsibility and is not liable for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence due to error, omission, tampering, deletion, theft, communications failure or otherwise. The promoter has no control over communications networks and is not liable for any problems associated with them due to traffic congestion, technical malfunction or otherwise.
